## **Primary Purpose**

Manage the operations of the school office and co-ordinate the school administrative service and assigned resources. Provide authoritative advice and support to the Principal and senior staff on administrative, resource and service management. Develop and implement operational solutions to meet administrative service requirements.

## Level of Responsibility/Direction and Supervision

As a member of the school management team the occupant is responsible for effective and efficient operational outcomes and for leadership and guidance of the administrative team. Responsible for the provision of authoritative advice to support service delivery requirements.



The occupant operates with considerable autonomy and independence in determining operational requirements within established guidelines, systems and processes, working with and under limited guidance from the Principal. Unit goals and objectives are established by the Principal. The occupant is required to understand and apply contemporary departmental administrative standards and is expected to keep up to date with developments and change in this area.

It is the responsibility of the occupant to actively participate, promote and model behaviours which are consistent with the Department's commitment to the safety and wellbeing of children and young people. This includes the prevention, identification and reporting of child abuse and behaviours which are not consistent with the Department's values.

The occupant is responsible for complying with all Agency policies and procedures, including those relating to fraud and corruption control, record management, confidentiality, conduct and behaviour, mandatory reporting, education, training and assessment.

The Department has a range of delegations across the operational portfolio's which include Finance, People Services and Support (HR) and Facilities. The occupant is responsible for ascertaining the delegations that are assigned to these duties and is expected to exercise any applicable delegations prudently and in accordance with a range of Acts, Regulations, Awards, administrative authorities and functional arrangements.

In the delivery of the department's activities, the occupant must ensure that:

- Within the occupant's area of organisational responsibility, appropriate strategies are in place to minimise the risk of fraud; and
- Decisions and actions are made ethically and with integrity, on the basis that such is lawful and reasonable, based on an objective standard; and
- Decisions and actions promote a culture that upholds the rights of children and young people, to keep them at the centre of the Department's work and protect them from harm.

## **Primary Duties**

- 1. Manage the daily operation of the school office and supervise, mentor and evaluate the performance of assigned non-teaching staff.
- Co-ordinate the delivery of school administrative services and provide effective and efficient administrative and executive support to the principal and other school staff. Provide authoritative advice to the Principal and other staff regarding general administrative, operational and resource issues and undertake relevant research and analysis as required.
- 3. Liaise and consult effectively with a wide range of stakeholders including government and non-government organisations, departmental Learning Services, school and community associations, bodies and representatives to build productive networks: represent the Department and school as delegated, prepare and provide reports and a range of communications for stakeholders as required.

- 4. In the context of the school operational framework provide significant support to the principal in the management of the school's administrative, human, financial and physical resources including school assets, inventory and assigned residences, split or off campus facilities.
- 5. As directed undertake planning, research, analysis and evaluation of complex resource management issues including school-based projects, programs and initiatives and prepare associated correspondence reports, submissions, grant applications and correspondence.
- 6. Apply Government & departmental policy by co-ordinating the development, implementation and evaluation of operational guidelines and solutions.
- 7. The incumbent can expect to be allocated duties, not specifically mentioned in this document, that are within the capacity, qualifications and experience normally expected from persons occupying positions at this classification level.
- 8. In accordance with the *Work Health and Safety Act 2012* the incumbent will actively participate in and contribute to the maintenance of safe working conditions and practices, including the development and implementation of improvement initiatives, safeguarding practices and all mandatory training requirements.

#### Selection Criteria

The following specific selection criteria must be addressed by candidates. The nominated position objective and duties contained in this statement of duties must also be used to assist in the interpretation of these selection criteria.

- 1. High level of proficiency in the provision of administrative, executive and program support services including staff and resources management, in particular budget management, financial and staff planning.
- 2. Experience in program and administrative co-ordination including the ability to effectively provide leadership, instruction and guidance for assigned staff.
- 3. In depth planning, research, analysis and investigative skills including the ability to evaluate, analyse and exercise independent judgement to solve often complex issues.
- 4. Highly developed interpersonal, verbal and written communication skills with the ability to provide clear and authoritative advice to inform and guide, together with the proven capacity to interact effectively with a wide range of stakeholders to develop effective networks.
- 5. Demonstrated capacity for initiative, innovation, self-motivation and flexibility and the ability to lead and encourage the development of a positive team environment.
- 6. In depth knowledge and experience of a challenging administrative operational framework and proven ability to deal with change management through the development and Implementation of operational solutions that meet service delivery requirements.
- 7. A demonstrated capacity to commit to the Department's values, with the ability to apply them through individual behaviours and actions.

## Requirements

Registration/licences that are essential requirements of this role must remain current and valid at all times whilst employed and the status of these may be checked at any time during employment. It is the employee's responsibility to advise the Department if there is any change to the status of a registration/licence. This includes notifying the Department of any new criminal charges or convictions and/or if a registration/licence is revoked, cancelled or has conditions applied.
