Employment Conditions	Permanent/Fixed-term, Full-time/Part-time, up to 73.5 hours per fortnight, up to 40weeks per year. The occupants of these positions work for the duration of school terms only, consequently, leave and other benefits are paid on a pro rata basis at the conclusion of Term 4 each year. Canteen Supervisors are covered by prescribed award arrangements and all provisions including TOIL prevail.

Primary Purpose

Supervise, maintain and deliver the school canteen services.

Level of Responsibility/Direction and Supervision

Responsible for the provision of a canteen service within a school in accordance with the requirements of the Canteen Handbook. Responsible for money received, maintenance of accounts and the ordering and receipting of stock.

Direction received from the Principal in relation to the provision of service and foodstuffs.

It is the responsibility of the occupant to actively participate, promote and model behaviours which are consistent with the Department's commitment to the safety and wellbeing of children and young people. This includes the prevention, identification and reporting of child abuse and behaviours which are not consistent with the Department's values.

The occupant is responsible for complying with all Agency policies and procedures, including those relating to fraud and corruption control, record management, confidentiality, conduct and behaviour, mandatory reporting, education, training and assessment.

The Department has a range of delegations across the operational portfolio's which include Finance, People Services and Support (HR) and Facilities. The occupant is responsible for ascertaining the delegations that are assigned to these duties and is expected to exercise any applicable delegations prudently and in accordance with a range of Acts, Regulations, Awards, administrative authorities and functional arrangements.

Primary Duties

1. Provide a high quality, nutritious and attractively presented canteen service to students and staff.
2. Maintain high standards of hygiene in the handling, preparation, serving, and storage of food.
3. Ensure appropriate standards of cleaning and maintenance are achieved at all times.
4. Undertake the preparation of food items.
5. Supervise other canteen staff as necessary including volunteers.
6. Control stock and inventories including the ordering and receipting of goods.
7. Maintain control of cash receipts and payments including the certification of accounts.
8. Liaise with the Canteen Management Committee to ensure appropriate pricing of stock, reasonable opening hours, equipment maintenance, etc.
9. Responsible for upholding and implementing the policies of the canteen.
10. Responsible for the security of the canteen, including money, keys and stock.
11. Ensure that products and services supplied by the canteen are marketed and promoted appropriately.
12. The incumbent can expect to be allocated duties, not specifically mentioned in this document, that are within the capacity, qualifications and experience normally expected from persons occupying positions at this classification level.

13. In accordance with the *Work Health and Safety Act 2012* the incumbent will actively participate in and contribute to the maintenance of safe working conditions and practices, including the development and implementation of improvement initiatives, safeguarding practices and all mandatory training requirements.

Selection Criteria

The following specific selection criteria must be addressed by candidates. The nominated position objective and duties contained in this statement of duties must also be used to assist in the interpretation of these selection criteria.

1. Experience in the provision of a canteen service to clients, including a sound knowledge of nutritional principles as they apply to children.
2. Sound knowledge and experience of hygiene standards, especially as they relate to food preparation.
3. Knowledge of inventory and stock management.
4. Capacity for handling cash transactions and maintaining accounts.
5. Proven communication and interpersonal skills with both adults and students.
6. Ability to work as part of a team, including the ability to supervise that team.
7. A demonstrated capacity to commit to the Department's values, with the ability to apply them through individual behaviours and actions.

Requirements

Registration/licences that are essential requirements of this role must remain current and valid at all times whilst employed and the status of these may be checked at any time during employment. It is the employee's responsibility to advise the Department if there is any change to the status of a registration/licence. This includes notifying the Department of any new criminal charges or convictions and/or if a registration/licence is revoked, cancelled or has conditions applied.
